28 Food program: Shared Hope for Orphans Worldwide (SHOW) was able to provide \$16,609.98 for food. These funds came from the food donors throughout the year and the monthly sponsorship program. With these funds, we were able to help feed the boarding students (around 200) 3 meals per day. It also helped to feed the additional day schoolers (200-250) their morning breakfast. At SHO-Uganda we are working with the team to create a self-sustaining primary school/orphanage where so they are able to feed and clothe orphans/needy children. The program currently is able to fully support 200 children between the funds that we are able to provide and the funds that they get from other day schoolers and boarding students. (Each term varies but there is anywhere between 200 and 250 additional students that attend the SHO-Uganda school). 29 Education program: Education is a key to the success of the project growing and becoming self-sustaining. Shared Hope for Orphans Worldwide (SHOW) was able to provide \$29,822.28 for education. These funds came from random donors throughout the year and the monthly sponsorship program. With these funds, we were able to help educate 400 students from pre-school through about 7th grade (P7 by Ugandan education levels). The program currently is able to support 200 orphan / needy children and each term varies but there is anywhere between 200 and 250 additional paying students that attend the SHO-Uganda school. The school's total enrollment is on average 400 students between those that are in need and the paying students. SHOW is also using education funds to purchase needed books and supplies. SHOW is also helping about 30 additional students to go to secondary school, special needs schools, or vocational schools. 30 Community Development Program: In 2019, SHOW was able to provide \$28,362.45 in funds for community development. One major thing that SHOW is doing in this area is walking step by step, with the SHO-Uganda staff, thru income-generating projects. By doing this we are empowering the people so that they are better able to budget for new projects and create increased incomes because they are able to learn business management. The 2019 year has been about to bring many changes to the groups and community around SHO-Uganda. SHO-Uganda and SHOW were about to partner and build and finish a few more buildings on the school grounds. The Organization was able to finish the office/nurse's buildings, start an older boys dorm and drill a well. We hope in 2020 to be able to pipe water to the water collection system, guesthouse and other taps for the children to get water from. There was also a mosquito nets and a septic tank installed for the guesthouse and a flushing toilet so guest can be more comfortable. To be able to better transport secondary students to school SHOW was able to purchase a used car for the organization in Uganda. It will be used to also transport any missionaries that decide to visit our project in Uganda. To help the project in Uganda to become more self-sustaining in 2019 we have rented a sugar cane field that will be able to help the project to make income for the next 5 years of the lease. Also, on the school grounds, we were able to plant about 200 banana trees that will be used to help feed the children but also have a cash crop.
