We believe in a holistic approach to giving people the opportunity to be free from oppression through prevention, intervention, and restoration programs. Our Children's Advocacy Center trains students to avoid abuse, keeps those safe who have been abused, and partners with law enforcement to stop offenders. Our Bakery and Salon train recovering individuals for a useful trade, and assist exploited persons from other countries with repatriation, all in Jesus name.

For Freedom International's primary focus for ministry growth and impact has been in the development of the Vocational Training Center in Phuket, in Partnership with local Thai churches. Funds were sent to fund a social worker to administer our Child Advocacy program to train students and teachers in preventing sexual exploitation, rescuing victims of child labor and sexual abuse and exploitation, and developing a foster care system in cooperation with the local church to care for children rescued from exploitation

4b (Code:) (Expenses \$ 11,200 including grants of \$ 0) (Revenue \$ 0)

For Freedom International made a donation of \$2,400 to Evangelical Fellowship of Thailand to sponsor a pastors training conference in S Thailand as part of our partnership with local churches in outreach and spreading the gospel while helping the exploited to find freedom through Jesus Christ.

An additional \$8,800 was expended to pay the expenses of a short-term mission trip for a US church that enabled us to increase awareness around the world of the nature and severity of the bondage caused by abuse and exploitation of children and adults and to encourage others to become involved in reaching the abused for Jesus Christ, and in freeing them from the oppression of their abuse and exploitation

For Freedom International made donations to For Freedom International of Thailand to support on-going programs related to the rescue and rehabilitation of exploited individuals as part of our stated objective to prevent exploitation, to assist those who have been exploited, to rehabilitate and retrain them for careers in baking or salon work. The amount sent for this purpose totaled \$6410

For Freedom International also made a \$25,000 payment for maintenance of a safe house, to provide a place for rescued individuals to safely stay during their time of recovery, rehabilitation, and re-training, making possible the freedom to move past the exploitation and forward to safe and productive lives.
