The Organization's mission is to mobilize the local community to help the neediest among us by supporting and enhancing the community system of services, programs, and facilities that work to prevent and make homelessness nonrecurring. The mission is accomplished through fund raising and providing resources into the community.

The organization provided a grant to the City of Virginia Beach's Department of Housing and Neighborhood Preservation to provide persons experiencing homelessness or a housing crisis access to Housing Crisis and Stabilization Funds. The Housing and Stabilization Program is a multi-functional homeless assistance program designed to connect persons experiencing homelessness or at imminent risk of becoming homeless to stable housing solutions, including the Housing Resource Center "(HRC)". Through this program, over 500 people were housed at the HRC, including 30 individuals that were permanently housed at the HRC apartments and 39 families and 234 single adults were sheltered at the HRC. Over 1,200 persons were referred through the program for housing or shelter assistance. Over 200 people were prevented or diverted from experiencing homelessness. Over 800 single adults accessed the day services at the HRC and over 290 patients were served at the health center located at the HRC. Over 35,000 meals were served to shelter and day services participants. Over 290 people were connected to employment services through the program.

4b (Code: ) (Expenses \$ 14,300 including grants of \$ 14,300) (Revenue \$ )  
The organization provided a grant to the Virginia Beach Education Foundation primarily to be used to supply "Beach Bags" weekly during the school year (35 weeks) to 133 students identified as homeless. Each bag contains 10 shelf stable food items to sustain the students over weekends and during school breaks. By keeping these most vulnerable students nourished over weekends and breaks, they return to school classrooms on Monday mornings alert and ready to succeed academically. During 2019, 14,510 weekend meals were provided through the Beach Bag program.

The organization provided a grant to Beach Faith in Action to provide a \$600 per month stipend to the Charity Tracker Administrator for one year. The Charity Tracker is utilized 35 faith based and nonprofit users to track funds and in-kind support to individuals experiencing homelessness within our community. With the help of the Tracker, communications has become much more efficient and homeless persons needs are met quicker. During 2019 over 1,200 persons were referred for housing or shelter assistance.

As the organization has been able to accumulate more funds they have been able to undertake more program services and provide additional grants and other services to assist the homeless. These additional grants that were provided in 2019 for the first time included Beach Faith in Action (more fully described in Part III, line 4c) as well as PIN Ministries and Together We Can Foundation (list on Schedule I).
