

Part 1 - Line 12: In 2019 Tim and Dar Ratzloff, the executive directors of Jumpah.org, continued as staff employees for Mountain View

Community Church as in proceeding years. They worked exclusively for Jumpah.org in advancing its program goals. The expense listed

on line 12 is what Jumpah.org reimbursed Mountain View Community Church for Ratzloff's compensation and employer related taxes

for the entire year of 2019.

Part 1 - Line 16: other costs include \$5,331 for office supplies, accounting software, licenses & fees, banking fees, and internet promotion

costs. This amount also includes partial reimbursement for the executive director's travel costs to Cambodia to inspect the project and to

advise and encourage the leadership and staff engaged in the program work in Cambodia.

Part III - Line 28: JUMPAH SCHOOL - Jumpah partially funded the operational costs (teacher salaries, school supplies, facility expenses, etc)

of the Jumpah School that provided a high quality and loving education to children from nine neighboring rural villages.

The Jumpah School is a private Cambodian government accredited school offering classes pre-school through sixth grade to children that

otherwise have little opportunity to receive even a basic education (reading, writing, math, etc.) in the local "public" schools. The enrollment

has increased from 324 students in 2018 to over 440 in 2019. Each family pays \$10 - \$13 tuition per student each month and Jumpah.org

funds the balance of the school's costs.

Part III - Line 28: WOOD SHOP & FARM - Jumpah.org also provided funds to develop the vocational training & employment for at least 8

local villagers at the wood shop. Jumpah also funded the expansion of a model farm that demonstrates economical methods in successfully

raising a variety of vegetable crops to supplement their single crop of rice. The farm employed about 8 local residents.

Jumpah.org transferred the above funds through a Cambodian government licensed non-profit local NGO (non-government organization)

under the same name "Jumpah".

Part IV regarding Tim & Dar Ratzloff's activity: Though the Ratzloff's served as Executive Directors for Jumpah.org, they continued to work

directly with the Jumpah program both at the project site in Cambodia and from their office in the US. They acted as consultants giving

direction and advice to the leadership and staff in Cambodia as they have for past several years.

Part IV regarding Tim & Kristine Scoville, they have spent several weeks in Cambodia assisting in development of the wood shop

worker skills as well as assisting the school with teaching materials and facility improvements.

Part IV regarding Rod Casel, Rod is an electrician and has traveled several times to Cambodia the past several years to install the electrical

systems in the various facilities at the Jumpah campus.
