GOING TO NEARBY SCHOOLS, PARKS, AND CHURCHES TO SHARE WITH THE COMMUNITY ABOUT OUR NEW LOCATION. WE WERE ABLE TO START BRINGING IN FAMILIES TO PARTAKE IN THE DANCE CLASSES ALL FREE OF CHARGE.
