WE BEGAN TO BUILD OUR OUTREACH THROUGH THE USE OF FLYERS, FACEBOOK POSTS, AND WORD OF MOUTH. GOING TO NEARBY SCHOOLS, PARKS, AND CHURCHES TO SHARE WITH THE COMMUNITY ABOUT OUR NEW LOCATION.
