The Foundation was formed during 2016, receiving its Determination Letter on/about July 29, 2016, with the result that the majority of the Organization's activities during 2016 and early 2017 related to organizational matters necessary to the implementation of the Organization's charitable purpose. As indicated in the Organization's IRS Form 1023, the Organization's activities, in furtherance of its mission, are expected to include providing for the physical and spiritual needs of the poor and disadvantaged people of the world, in the United States and Central and South America, with the specific activities expected to include the construction of structures (dwellings, schools, and churches), from the planning stage, to implementation, to post-construction support. This mission continues the charitable works of the Founders who have expended significant time, energy, and funds in promoting spiritual health and growth and education in Guatemala, including providing the funds for a school in Guatemala to expand and add a second floor to its existing structure.

The Foundation does not believe that its current charitable activities has changed from that described in its Form 1023, however, the current focus of the Foundation has shifted to the spiritual needs here, in the United States, particularly as we deal with the COVID-19 emergency at the time this return is filed. While the Foundation expects to continue its missions in Central and South America, the Foundation believes that its current efforts to grow a (non-denominational) church community which is currently operating at a temporary location in Baton Rouge, LA (i.e., a school gym which they are allowed to use temporarily for services), is not only important to spiritual needs of the Baton Rouge community, but will also serve as a means to grow (both in terms of financial strength and manpower) the resources necessary to continue to promote spiritual health and well-being in other parts of the World. As a result, the primary focus of the Foundation, beginning in 2018 and continuing in 2019, has been the acquisition and preliminary site work (in 2018) and architectural planning (in 2019) for construction of a new Church structure, with those efforts to continue into 2020. The Church structure would then be leased to Hope Church, with the lease amount to initially be at a rate below market value, until the membership of Hope Church grows and can support a market value Lease or potentially purchase of the Church structure. The intention is that the Lease ultimately generate income that will allow for the continued funding of missions in Central and South America and other locations throughout the World. Further, Hope Church has established a commitment to the same missionary work to be fostered and supported by the Foundation. Hope Church has "adopted" a Church in Guatemala and provides outreach programs and other services to the Guatemalan Church and community that creates a harmonious synergy with the mission and purpose of the Foundation.
