1. In Springdale, AR, Pastors Philip Derber and Destinor Antoine ministered in the Marshallese Winter Conference, 1/28-2/2/19. Prophesying, preaching the Kingdom, healing, deliverance, the standard of living continues to increase. They also counseled many pastors about how to Advance the Kingdom. Six meetings were attended by 100 individuals in the morning services and 250-300 in the evening. \$907

2. In Harrisburg, PA Pastor Philip Derber ministered at Church Without Walls Conference 2 services, approximately 300 people each, prophesying, preaching, and praying for needs. One of the results of his ministry resulted in a name change for the church. \$1442

3. In Galion, OH, 2/23-2/24/19, Pastors Philip and Alberta Derber and the RVN Band ministered 2 services at Victory Rock Church, performing funeral and doing the Sunday morning service. 120 people attended the funeral and approximately 150 people attended the Sunday service. Pastor Philip preached and Pastor Alberta prayed for the needy. They counseled with the pastors and spent quality time with the surviving spouse. \$1463

In St. Petersburg, FL, 10/21-10/28/19, Pastors Philip and Alberta Derber ministered at the Exceeding Grace Christian Center Fall Conference for 4 services, approximately 100 people in attendance in each meeting. They preached, prayed for healing, financial miracles and counseled with the pastors. The church is prospering in many ways as a result. \$1706

5. In Enid, OK, 10/9-10/14, Pastor Philip Derber ministered in the Marshallese Conference 6 services with approximately 80 people in the morning services and 150 in the evening services. Many healings, prophetic ministry changing lives occurred. \$1472

6. In Harrisburg, PA, 11/7-11/11/19 Pastor Philip Derber ministered in the Legacy Faith Church, Takeover Conference for 2 services, preaching prophesying, and praying for needs.
