Katmai Conservancy is the official philanthropic partner of Katmai National Park and Preserve in Alaska. We raise and administer funds to support the Park and its programs. These programs include education (both inside and outside the Park), live streaming bear cams, scientific and historical research, community outreach and youth engagement. The Conservancy also provides funding for park infrastructure.

Katmai Conservancy provided funds for the Katmai National Park to hire media specialists and interpreters. These employees provided interpretations programming and assisted with the operations and interpretation of the Explore.org live streaming bear cams. These employees enabled an extensive online presence including live chats on bears and the natural environment within the Park. Other activities were monitoring the online chat room, publishing an e book on the Bears of Brooks Falls, and coordinating the end of season Fat Bear Contest. The online activities reached over 2 million viewers.

4b (Code:) (Expenses \$ 11,000 including grants of \$) (Revenue \$)
Katmai Conservancy provided funds to help finish the new bridge across the Naknek river at Brooks Camp within the Park. This bridge now provides a safer and more use friendly visitor experience for Park visitors who come to view the bears. Our funds helped run new communication cables from park headquarters to the visitor bear viewing platform and live streaming Explore.org bear cams.

Katmai Conservancy participates in community programs in the gateway community of Bristol Bay Borough. This year we participated in the annual Fishtival celebrating the end of the salmon run, Bristol Bay Expo - a fund raiser for local children, and also hosted an end of season community get together featuring the Park and the indigenous communities.
