This space is used by members for their own independent research projects as well as by members of the public who wish to participate in community projects that help to engage locals in citizen science. SoundBio currently has over five independent research projects underway as well as two communitiy projects with meeting attendance between 2 and 10 people each session.

These events reach a variety of audiences, often targeting middle school age and below as well as reaching low-income communities that otherwise don't get much exposure to hands-on science learning. In 2019, SoundBio attended 13 tabling events throughout the city, engage 65 volunteers, over 200 volunteer hours, and reached 1,200 individuals across the community.

SoundBio hosts a high school iGEM team within the lab. iGEM is an international synthetic biology competition that provides the students hands-on, real world experience in running a full-scale research team, from fundraising, product development and design, gathering stakeholder input, and communicating their work to the public, in addition to conducting the scientific work. In 2019, the team had about 15 students who each worked an average of 8-12 hours per week to move the project forward before presenting their work in Boston.
