NJJN'S PUBLICATIONS CENTER RACE EQUITY AND A FOCUS ON OUR MOST VULNERABLE. NJJN ALSO CONTINUES TO PUSH THE YOUTH JUSTICE FIELD TOWARDS ANTI-RACISM. IN 2019, WE CONTRACTED WITH AN ANTI-RACIST RACIAL JUSTICE CONSULTANT WHO WORKED WITH OUR LEADERSHIP TEAM TO DEVELOP ANTI-RACIST BENCHMARKS FOR OUR MEMBERSHIP. NJJN ALSO WORKED WITH A YOUTH CONSULTANT AND HIRED A YOUNG LEADER COORDINATOR TO DEVELOP YOUTH PROGRAMMING.
