STUDENTS REPORTED A 50% INCREASE IN FEELINGS OF CLOSENESS TO THEIR PEERS FROM THE OTHER SCHOOL AFTER HAVING REPORTED FEELINGS OF SUSPICION AND ANXIETY BEFORE THE PROGRAM. MUCH OF OUR PROGRAMS ARE INFORMED BY THE EXPERIMENTAL WORK IN THE FIELD EXCHANGE. THE IMMERSION WEEKS ALSO SERVE AS OUTREACH EVENTS THAT HELP RAISE AWARENESS OF NARRATIVE 4 IN THE SCHOOLS' COMMUNITIES.
