volunteer Treasurer, without prior experience, I was unaware of the Federal requirements regarding timely payments.

When I retired in 2020 I became familiar with Form 941, submitted the missing quarterly payments, and produced a W-3 and W-2.

However, there is no expense item associated with paying FICA in 2019, because it was paid in 2020. Also, no Federal or State income taxes were withheld in 2019. Use of net wages allows for the reconciliation of Net Assets required in Part IX. On 6/14/21, I submitted

a revised W-3c and W-2c, because I discovered I had recorded some numbers incorrectly, and also failed to report one paycheck.

This came to light when I was preparing to submit this Form 990 for 2019. On 6/10/21, I also submitted Forms 941-X for Q2, Q3 and Q4 to correct withholding. A second omitted paycheck was then discovered in Q4. See explanation below for Part X for more detail.
