The organization supports Boy Scout Troop 100 ("Troop 100"), located in Seattle, WA. Troop 100 includes approximately 60 active Boy Scouts. Accomplishments in 2019 included the Scouts earning 252 merit badges, 51 rank advancements, including 2 new Eagle Scouts, the highest rank in Boy Scouts. Troop 100 went on multiple camping/hiking trips including a 13 day trip to Switzerland to visit the International Scout Center in Kandersteg. Other activities included multiple "Guys Night Out" events, winter camping, Summer Camp, Family Camp, Camporee, laser tag and skiing. Troop 100 held weekly meetings with a variety of activities for the Scouts, including multiple Courts of Honors where the Scouts were recognized for their merit badge achievements and rank advancements.
