It also inspires our Veterans at risk to be motivated by seeing the successes of other Veterans, after the uniform. We hold true to our mission "a help up not a hand out sytem" as these projects are the first vital step. Phase two: take motivated Veterans and prepare them for the work force and/or put them to work with fellow Veterans or our cummmunity neighbors.
