Statement of Reasonable Cause for Late Filing (pursuant to Revenue Procedure 2014-11)

Save the West, Inc. engaged the law firm of Putney, Twombly, Hall & Hirson LLP to incorporate in New York. The corporation was formed on September 28, 2016 under the Not-For-Profit Corporation Law. This law firm was engaged and prepared Application for Recognition of Exemption under Section 501(c)(3) of the Internal Revenue Code (Form 1023) that was mailed to the Internal Revenue Service ("IRS") on or about June 2, 2017. The IRS issued a favorable determination letter granting tax exemption under Section 501(c)(3) of the Internal Revenue Code effective September 28, 2016 (date of incorporation).

Save the West, Inc. was inactive during 2016 and 2017 and the corporate officers were not aware of Form 990 series (i.e., Form 990-N) returns were still required to be filed with the IRS to maintain tax exemption. It was only when Save the West, Inc. engaged the public accounting firm BDO USA, LLP to prepare annual return Form 990 for 2018. After preparing 2018 Form 990, BDO obtained e-file signature authorization (Form 8879-EO) and on or about November 14, 2019 BDO attempted to e-file Form 990 with the IRS and it was rejected. BDO made inquiry as to why it was rejected and determined that the IRS had revoked the tax exemption effective May 15, 2019 for failure to file Form 990 series returns for three consecutive years.

During this time one of the officers of the corporation moved from Connecticut to Florida and it appears that the IRS communication of the Notice of Automatic Revocation of Tax Exemption dated August 19, 2019 (date of revocation being May 15, 2019 that is the original due date of the third consecutive year Form 990 series return for calendar year) was delivered to the previous old address and not forwarded to the officer.

Save the West, Inc. engaged BDO to prepare necessary filings to request retroactive reinstatement of tax exemption. During this time BDO discovered that it was necessary to amend 2018 Form 990/990-EZ because it failed to include contribution revenue from a donor's brokerage account before 2019 Form 990/990-EZ could be prepared.

Save the West, Inc. has taken appropriate measures to help ensure timely Form 990/990-EZ filings.

The failure of Save the West, Inc. to file its final Form 990 was due to reasonable cause and not willful neglect.

Additionally, Save the West, Inc. seeks penalty relief under Section 20.1.1 of the Internal Revenue Manual. It represents the following:

1. Save the West, Inc. didn't previously have penalties for the 3 tax years prior to the tax year in which they received a penalty.

2. Save the West, Inc. filed all currently required returns or filed an extension of time to file.
3. Save the West, Inc. has paid any tax due. (Note, Form 990/990-EZ is an information return and has no tax liability.)

The Internal Revenue Service should recognize that the insistence of collection of the penalty assessment would be a harsh punishment under the present circumstances. Payment of such penalty would be a hardship for Save the West, Inc., since every dollar is needed by them to continue in their mission. (e.g., To advance knowledge concerning (1) the foundational underpinnings of Western Civilization ("The West"); (2) the identities of The West's enemies, their strategies, tactics and objectives; (3) common-sense solutions that will enable The West to survive, and ultimately, thrive; (4) how freedom-loving people in western nations can help save our culture.

Therefore, with due consideration to the facts and circumstances as described herein, Save the West, Inc. respectfully requests an abatement of the Form 990 late filing penalty.
