CATALYST SCIENCE FUND Through this fund, Revive & Restore supports early stage highly innovative research aimed at advancing the science of wildlife conservation. The goal of these grants is to test the feasibility of new technologies and approaches to genetic rescue of wild species. In 2019, Revive & Restore awarded seven grants to talented researchers with projects that aim to increase the genetic diversity of the endangered black-footed ferret (in collaboration with USFWS), optimize advanced reproductive science for genetic rescue and de-extinction of wild bird species (with Texas A&M), create experimental platforms for vaccine development for elephants (Harvard), and test innovative methods for making gene edits directly to embryos using stem cell technology (UC Davis).

Form 990, Part III, Line 4b:

OCEANSAFE FEASIBILITY STUDY Revive & Restore conducted a feasibility analysis for a potential grand challenge program aimed at biobanking (cryopreserving) and genome sequencing all marine organisms. This study assessed current technical capabilities and limitations, as well as the relevant regulatory aspects of such a large scale, global effort. The resulting report identified several technical limitations that represent grand challenges for marine wildlife conservation. Revive & Restore then developed proposals for projects that could address six of those grand challenges and improve the scale and economy of marine wildlife protection initiatives.

OCEAN GENOMICS HORIZON SCAN In June 2019, Revive & Restore published the Ocean Genomics Horizon Scan, a first-of-its-kind report on the potential for biotechnology to transform marine conservation. While our research makes it clear that the ocean is under significant threat, the 168-page Horizon Scan gives us hope for the future. After nine months of research and interviews with over 100 experts, our findings led to the synthesis of Ten Big Ideas, each an actionable project that has the potential to turn the tide on the ocean's decline. These Big Ideas use genetic insight, genomic intervention, and biotech applications to advance conservation in ways we could never have imagined until now. By the end of 2019, we had already raised funding interest in several of these projects which we will initiate in 2020.
