Looking at youth outcomes from 160 programs across 11 state afterschool networks supported by STEM Next, a study conducted by Harvard's program in education, afterschool and resiliency (PEAR) and Texas Tech University's Institute for Measurement, Methodology, Analysis and Policy, showed that more than 70% of students reported positive gains in STEM areas such as science interest, career interest, science identity, and 21st century skills. More than 95% of program facilitators felt their students made significant improvements in skills and confidence in math, science, and social settings. Further, afterschool and out of school programs can almost double the time that some students have to question, tinker, learn and explore STEM topics.
