This year, the Organization provided shelter to five indigent families and one individual at no-cost to the indigent persons. The Organization does not charge rent, so there are no revenues associated to with this program service. Total expenses to provide these services were \$34,376, which primarily relate to paying the utilities and operating expenses for the homes, as presented and disclosed in the financial statements in Part IX. There was also a non-cash contribution expense of \$88,000 in 2019 related to the donation of one of the Organization's homes to an indigent family of four who had financial hardships to help support the family. Total in-kind (non-cash) contributions received related to the payment of utility expenses for some of the residential properties paid by the 501(c)(3) organization that St. Nicholas Charities supports as a Type-1 509(a)(3) organization, and the donation of one residential property that was donated to St. Nicholas Charities for its charitable purposes during the year.
