A Grant Contracting Process Summary provides detailed instructions and guidance for the Board and Scientific Advisory Board (SAB) as they seek new, cutting-edge therapeutic approaches for treating and preventing Parkinsons Disease in GBA mutation carriers. The SAB, which guides decision making in the selection process, is comprised of eleven (11) world renowned researchers and drug-developers. They are able to rapidly comb through GBA-related research to advance our goals and determine which grants shall be awarded. The Grant Contracting Process outlines the steps the Foundation takes to substantiate amounts and eligibility as follows; Primary Investigators (PI's) are asked to submit a detailed research plan and complete milestone and budget templates which are reviewed by Foundation staff and SAB members. Budget justification may be required. For private companies, high-level financial documents are requested in order to provide confirmation that the company has financial stability throughout the duration of the grant and beyond. Once all documents are received from grantee, internal review by all scientists ensures that all requests and goals are appropriate. A contract template, which includes payment schedule, is completed once all documents have been vetted by internal staff. A payment schedule is determined and payments are based upon milestones and deliverables being met. Clear go/no-go points for the research are required. Final executed contract, including budget and milestones are signed by the Foundation and the grantee, and are kept on file. Foundation personnel are assigned to oversee the progress of the grant, both scientifically and administratively. Progress updates, check-ins and reporting requirements are outlined and agreed upon in the contract and are monitored closely by personnel.

The Silverstein Foundation for Parkinson's with GBA maintains a rigorous grant management process which involves the following steps: Identify point of contact (POC) internally and communicate this to grantee. Payments will only be released if milestones are met. Grantee will need to stay in touch to share updates. Adjust payments if milestones are delayed. If work cannot continue, modification of work or early termination of grant would be required. Upon confirmation that payment can be sent, inform Foundation Treasurer (Natalie Silverstein) three (3) days in advance to issue payment. Share grantee name, amount and bank information. During midpoint and final report submission, ensure all high-level data, findings and results are shared in written form, even if grantee plans to share information via phone or in person during assessment meeting.
