Part 1, Line 10: The Parrot Posse donated food, cages, toys, perches, veterinary care, and other needed items to 55 separate entities to help approximately 3500 captive parrots in the US in need. This included supplies and medical care for almost one thousand parrots seized by 19 animal control agencies in 16 states across the US. We use, as much as possible, our wholesale accounts and other sales to stretch our donors' dollars as far as possible.

Part 1 Line 16: the corporation paid an annual \$50 registration fee to State of South Carolina.

Part 1, Line 8: the corporation received a \$450 store credit from ANuts.com, \$350 from Amazon Smile, \$1890 cashback from our Mastercard, and \$1,770 in Rewards Point dollars from MyBirdStore.com.

Part 1, Line 20: \$3660 was owed on credit cards on 12/2119.
