The program provides aid for a wide range of physical, mental health, behavioral, and/or learning disabilities. Through mounted activities it is seen that clients are able to physically enhance strength, flexibility, and balance while mentally the benefits of improved trust, confidence, and emotional support are gained. Unmounted activities or Equine-Assisted Learning (EAL) is an experiential learning approach that promotes the development of life skills for educational, professional, and personal goals. Additionally, the program offers vocational opportunities for those over the age of fourteen who are interested in learning more about horse care.
