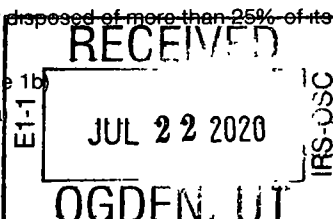

A MAJOR ANNUAL CONFERENCE, MOTORMORPHOSIS (AS AN NCC/I-ASC EVENT), WITH OVER 300 ATTENDEES WAS HELD IN JULY OF 2019. FOUR SUCCESSFUL HUB OUTREACH EVENTS WERE HOSTED IN 2 DESIGNATED LOCATIONS THAT FOSTERED OVER 200 ATTENDEES. OUR LEADERSHIP CADRE CAME TOGETHER IN 3 SUMMITS TO ENCOURAGE LEARNING FOR THESE 8 MEMBERS AND OUR FULL-TIME STAFF OF 3. ALONG WITH BRINGING INDIVIDUALS TO OUR CONFERENCE, WE HAD STAFF AND LEADERS ATTEND AND PRESENT AT 5 CONFERENCES IN 2019, REACHING LARGE AUDIENCES.

LEADERS WERE TRAINED DURING 3 FACE TO FACE WORKSHOPS IN ADDITION TO FREQUENT ONLINE CONTENT COLLABORATION SESSIONS. A REPLICABLE PROGRAM TO TRAIN INDIVIDUALS TO BE REGISTERED S2C PRACTITIONERS WAS DEVELOPED AND IMPLEMENTED. FOR EVERY 100 PRACTITIONERS TRAINED, WE ESTIMATE THAT APPROXIMATELY 30,000 NONSPEAKERS ARE HELPED (ESTIMATING THAT EACH PRACTITIONER WILL SEE 15 CLIENTS PER YEAR FOR AN AVERAGE 20 YEAR CAREER). WE BEGAN ONE SUCCESSFUL COHORT IN 2019 WITH 7 STUDENTS SUPPORTED BY A FACULTY OF 8 PREVIOUSLY TRAINED PRACTITIONERS. PLANNING AND DEVELOPMENT IN 2019 WILL LEAD TO 10 COHORTS RUNNING IN 2020.
