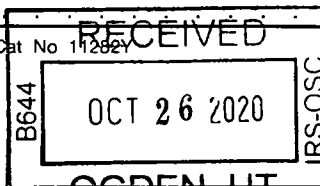

Transitional Housing:

During 2019 Leah's Hope provided transitional housing for four families. This included four single mothers and ten children. Apartment rent and utilities were paid for each family. Each apartment was insured, including a rider for the client. Each apartment was furnished for the client, articles included couch, coffee tables, and end tables; kitchen table and chairs; beds night stands, and dressers for each bedroom. All kitchen equipment was provided for each family, including a microwave. Dishes, silverware, pots and pans, and kitchen utensils were furnished as needed. The clients were allowed to take the furniture and kitchen equipment when they completed the program.

Programming Classes:

Classes were offered throughout the year. Classes included the Boundaries Series (Boundaries for Living, Boundaries with Kids, Boundaries in Marriage, and Boundries in Dating), Managing Finances, Money Matters for Teens, and Life Skills classes as needed. Life Skills classes are provided to learn about abilities and behaviors that help all of us effectively deal with the events and challenges of everyday life. They are also the skills that allow us to handle everything from interactions with others to identifying and processing emotions.

These classes were offered to program recipients, partnering churches, and nonprofits and the general public. We served 65 adults and children in the various classes in 2019.

Leah's Hope, Inc. - Transitional housing beneficiaries are required to esrow up to 20% of their income while they are a receipient into an escrow account monitored by Leah's Hope, Inc. at First State Bank, Midwest City, OK. Per the contract the beneficiary signs, the amount will be presented for deposit at least monthly. The money is deposited at First State Bank, in a designated escrow account. When a client completes the program, the escrowed money is given to them and they will use that money for their deposit and first month's rent in their new home. All funds are controlled by the Executive Director and Accounting Manager.

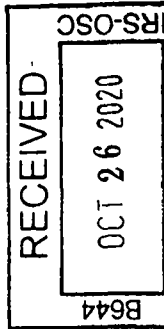

Recipients are closely monitored on a weekly basis, through home visits and case management meetings to ensure that resources are being used to appropriately. Weekly records are kept on each resident. Financial records of expenditures are archived and managed in the nonprofit office.
