YOUTH & EDUCATION: Youth & Education is one of the Foundations primary focus areas. The Foundation is committed to ensuring students have the chance to learn and explore all educational opportunities, and more specifically, pursue STEM-related careers. To deliver upon this work, the Foundation invested in the development of an Educators STEM initiative, whereby educators are exposed to the STEM pipeline opportunities for their students as well as resources to help connect in-classroom curriculum to real-world problem solving. In its capacity as a convener, the Foundation identified and cultivated collaborators from the for-profit, nonprofit and academic sectors. Working together, an Educators STEM Open House concept was developed, planning undertaken in 2019 for an early 2020 launch. The Foundation also directly invested in the future of youth education through scholarship funding for children of fallen and disabled service members.
