PROGRAM 3 – TED-Ed

TED-Ed also educates students in over 130 countries by helping them to identify, develop and present their own ideas in the form of TED-style talks. There are currently more than 13,000 TED-Ed Student Talk groups, and the program has supported hundreds of thousands of K-12 students in developing their ideas while learning invaluable presentation literacy skills. Two other programs, the TED-Ed Innovative Educator Program and the TED Masterclass offer professional development programs for innovative educators and learning leaders within schools, districts, and educational organizations. Led by an internal team of researchers, educators, creatives and strategists, TED-Ed is helping to change the face of education worldwide and to improve the education outcomes and future potential of millions of learners, young and old.

PROGRAM 4 – TEDx

They educate and train TEDx teams to help them achieve a high standard of event production and talk curation.
