TRAINING. Training is a huge ministry for us. We're able to train pastors, leaders, teachers, Sunday School teachers, VBS teachers, principals, musicians, and so many more. These are the ones who have a great impact in their community and the people that they minister to. In 2019 we were able to participate in training over 800 people. These people, with the knowledge they gain through our trainings, are able to go back to their schools, to their churches, into their communities, into their neighborhoods, and teach what they've learned to make this world a better place; to fill this world with people who fear and love God and in return will love and respect those around them.

Annually, we hold one Bible Conference, one Pastors Congress, and one Youth Camp; additionally we hold a weekly, year-round seminary accredited Bible Institute. We also have a 10-month sewing class, with classes at least twice a month and sometimes more. This allows us to provide 20 women with lessons on how to sew using a sewing machine. At the end of the 10 months,

they get to take home the machine as part of their graduation. This enables them to sew to bring in an extra income for their families. The ripple of fact we are seeing through these training programs has been massive! These people who are helped and trained are later on able to help and train others, who, in turn, help and train others.

HAPPY TUMMIES. Happy Tummies is an afterschool program for children where they receive lunch, a Bible lesson and after that we do tutoring with them for their homework and other class projects. They're also taught the importance of good personal hygiene, good morals, and how to be an exemplary citizen as they grow. In 2019 we fed over 300 children daily, most were fed lunches and some of were fed breakfast but everybody got a multivitamin and a full healthy nutritious meal.

They are also provided with a daily vitamin and a daily nutrition drink. We also teach them about good hygiene and encourage them to share with their families the importance of simple things such as washing their hands, showering daily, and brushing their teeth. We encourage the children to expand their horizons by giving them extracurricular activities, taking them on field trips; we hope to help them to be better than the generation before. We do not want them to lose their roots and therefore we encourage them to learn about their own culture.

Once the children are older and adults of the community, we hope to see them become teachers, doctors, principals, taxi drivers, salespeople, mechanics, butchers, and maybe even the mayor or the president. Most importantly, we want them to be honorable, trustworthy, and just Christian people.
