During 2019 Legislative Session, collaborating with the community members, we met with Governor Chief of Staff to discuss community and coalition policy priorities particularly the General Assistance rule change. This summer Governor Janet Mills announced new rules relaxing restrictions on General Assistance eligibility to allow more asylum seekers to qualify for the welfare benefits, reversing a LePage administration policy in response to a recent surge in migrants. MIRC worked together in supporting the following bills that passed: LD 1841, LD 1685, LD 1596, LD 1475, LD 777. LD 647 was carried over to next year. MIRC opposed the following that were successfully defeated: Bills to amend constitution to prohibit noncitizen voting in local elections, Mandatory E-Verify for all employers in Maine. A bill to require state/local police to do immigration law enforcement never brought to a vote on the floor. |
