In 2019, Swarm Baseball Foundation encompassed 19 baseball teams comprised of approximately 175 players. The team age range is between 8 years old and 14 years old. On average, each team participated in two organized tournaments a month and two or more practices a week for 9 of the 12 months of the year. Some teams also participated in league play.
