Lever Foundation worked with major food companies to inspire and help them remove the worst forms of animal cruelty from their supply chain, with a particular focus on helping companies commit to ending the use of battery cages (or other cage confinement of egg-laying hens) in their supply chain. In 2019, Lever Foundation was able to secure commitments from several major food companies to end the use of cages in their egg supply chain, policy shifts which will spare hundreds of thousands of animals per year from the acute cruelty of battery cage confinement. Because one out of every four laying hens alive today is living in China, and because there has been very little work done to advance this issue in the region, Lever Foundation focused its efforts on achieving these policy changes in the greater China region and throughout Asia generally. The policy changes generated by Lever Foundation's program work in this area in 2019 will spare millions of egg-laying hens per year from the acute cruelty of battery cage confinement. Note: expenses are a rounded approximation, as many program expenses span more than one program area.

4b (Code:) (Expenses \$ 225,000 including grants of \$ 200,000) (Revenue \$ 0)
Lever Foundation worked to grow the "alternative protein" space (plant-based meat, egg and dairy products, and "clean" meat, egg, and dairy products that are produced from cellular agriculture or fermentation without the need for live animals) by assisting entrepreneurs with starting companies in the space, helping startups secure investment funding, and directing more investor interest and investment dollars to the alternative protein space. Lever Foundation also worked with major food companies to promote adding more alternative protein options. Because one out of every two farm animals alive today is living in China, and because this market is very under-developed in China, Lever Foundation focused its efforts on growing the alternative protein space in the greater China region. Because of the nature of this work, it is hard to estimate a specific number of animals that will benefit from work done in this area by Lever Foundation in 2019. Note: expenses are a rounded approximation, as many program expenses span more than one program area.

4c (Code:) (Expenses \$ 10,000 including grants of \$ 0) (Revenue \$ 0)
Lever Foundation worked to promote interest in plant-based foods through working directly with companies and institutions to shift more of their purchasing toward plant-based foods, and through promoting to the public the benefits of eating more plant-based foods. Because one of every two farm animals alive today lives in China, and because there has been very little work done to advance this issue in China or Asia generally, Lever Foundation focused its efforts on promoting plant-based foods and plant-based eating in the greater China region. Because of the nature of the work, it is hard to estimate a specific number of animals that will benefit from work done in this area by Lever Foundation in 2019. Note: expenses are a rounded approximation, as many program expenses span more than one program area.
