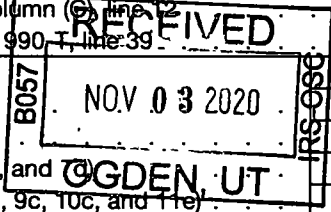

Makerspace  
The Maker Nexus makerspace provides access to 3D printers, laser cutters, home and industrial textile equipment, an electronics bench, a comprehensive woodworking shop, a metalworking shop, a computer lab, and meeting space. The makerspace opened for community use in April 2019 with selected equipment, the woodworking shop became operational in September 2019, and the metalworking shop is still under development.  
Maker Nexus members pay a monthly or annual fee for access to all the makerspace tools and equipment for their own projects. Our experienced staff maintains the machines in excellent working order and are always available to lend a hand or provide advice on how to effectively use a tool.  
When the makerspace opened in April, Maker Nexus had 30 members. Membership increased steadily for the rest of the year, and the year ended with 180 members.

Education  
Maker Nexus fulfills its educational mission through formal skill-building sessions, informal learning opportunities, and STEAM (Science, Technology, Engineering, Mathematics plus Arts) enrichment programs that emphasize inquiry and problem-based learning methods used in the creative process.  
Maker Nexus offered 41 different types of skill-building and enrichment sessions in 2019 with 515 total enrollments. Sessions ranged from instruction on basic operations and safety for equipment to projects involving design and prototyping.  
Maker Nexus also conducted two larger enrichment programs in 2019.  
The first was a Delivery Robot camp, sponsored by Amazon Lab 126, targeting minority and underserved youth. The 35 attendees were mainly young women grade 9 - 11. The students were introduced to design concepts, basic robotics, and programming. In three weeks, they designed, built, and programmed their robots in small teams of four. The camp concluded with a challenging obstacle course the robots needed to navigate while picking up a package at one spot and delivering it to another.
