Last year, 19 scholarships were awarded. c) Another workforce program is a public health dentistry fellowship offered annually to three Marquette dental student graduates that serve for one year at two safety-net clinics.

Access to dental care - Due to Wisconsin's low Medicaid dental reimbursement, finding a dentist that will accept public insurance is extremely difficult. a) The Foundation awarded grants to 18 safety-net dental clinics that provide care to individuals who are uninsured or have Medicaid coverage. Grants are awarded for new or expanding nonprofit dental clinics, as well as those who need sustaining funds for caring for individuals with special needs or other innovative programs. These clinics treated approximately 50,380 low-income individuals in 2019.
