28 Since opening its doors in June of 2019, Elk City Playhouse, the adopted home of the Contemporary Youth Arts Company of Charleston, WV has produced five major original productions, four on site, providing teens and young adults with 70+ roles for a combined audience of over 1600 In addition to 3 rehearsals per week, weekly master acting classes provided advanced training to an average of 7 students per class, plus a smaller beginners class of 3-4 More importantly, the Elk City Playhouse, became a second home and artistic sanctuary for the 40-50 regulars who participate in classes or plays or musicals or help build the sets and stages and move seats around and clean up the place after the shows Many of these young people actually helped build the stage, the stairs, the platforms, and the railings and it is, therefore, very much theirs One of the many young artists among them has painted an enormous mural in the theater lobby depicting moments from eleven of the nearly seventy original works created by CYAC over the years Others have directed their first pieces on this stageincluding one of the four social action plays that had been scheduled to open this month until the corona-virus froze everything The Playhouse is a place where art and being an artist is discussed openly and honestly In a world where the weirdly artistic young people are shunned from the mainstream, the Playhouse has consistently allowed young people complete freedom of expression, and has used the genius of so many of its participants to become the inspiration for others of their kind (Grants \$ 0)	28a	79,445
