Mike Guardabascio has been writing professionally for 15 years. His work has been published in dozens of Southern California magazines and newspapers. He's won numerous awards and is the author of the book *Football in Long Beach* and co-author of *Basketball in Long Beach*. JJ Fiddler is an award-winning professional sportswriter and videographer who has been covering Southern California sports for multiple newspapers and websites since 2004.
