Explanation: Taxpayer is filing a delinquent 2019 Form 990-EZ having foregone the extension period and is requesting that no late filing penalty be imposed due to "reasonable cause." The individual who formed the foundation is responsible not only for the administrative functions but for every aspect of the foundation's operations. This individual has no experience in the area of tax compliance and was unaware of the filing requirements for Form 990-EZ. In addition, all contributions made to the foundation are used for charity. Assessing a late filing penalty would simply reduce the amount available for charitable purposes. In light of the above circumstances, we respectfully request that you not impose any late filing penalties.
