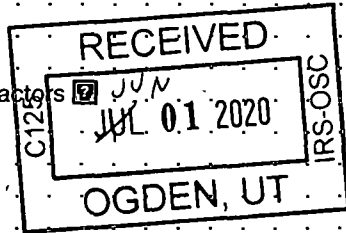

Part III Statement of Program Service Accomplishments

Line 28: We provided a grant to the Seng Girls Vocational Training School (based in Qinghai, China). This funded 50% of the total costs of vocational schooling for 60 disadvantaged girls in 2019. The funds included the 50% financing of 9 teacher salaries, girls food, books, utilities etc.

Line 29: (1) We provided a grant to 3 ANGELS NEPAL fully funding (100%) the operation of the Women's Safe Haven program in 2019. This program gave short to medium term aftercare support, counseling, and accommodation to 60 victims of human trafficking throughout the year.

(2) We provided a grant to the 3 ANGELS NEPAL MY BUSINESS - MY FREEDOM Microfinance program. This provided loan capital to the program enabling 15 women to join the program and receive training, advice on setting up a business, and a small business loan.

Line 30: We provided a grant to TINY HANDS NEPAL supporting 70% of the total operating costs of 5 monitoring stations on the indo-Nepal border. These stations intercepted/stopped 278 women who were assessed as showing high risk factors indicating they were likely in the very process of being trafficked into India. Our support also funded the arresting and conviction of 6 traffickers with the help of police as well as court representation for victims of trafficking.
