Schedule L, Part I, Line 1	Taxpayer is evaluating recent allegations of excess benefit compensation and unauthorized expense reimbursement. As part of its remediation efforts, Taxpayer has engaged the professional assistance of a forensic auditing firm, legal counsel, and a new CPA. Taxpayer also has a new CEO and Treasurer. All of these individuals and firms have assisted the Taxpayer with efforts to change its governance and policies. Specifically, Taxpayer is in the process of adopting a revised Certificate of Formation and Bylaws which establish a Treasurer, and Finance and Audit Committee, separate from the CFO. Taxpayer also has approved new or revised policies concerning conflicts of interest, whistleblowing, executive compensation (consistent with Treas. Reg. 53.4958-6T), and travel and expense reimbursement. Structurally, Taxpayer has taken steps to end a cost-sharing agreement with United in Purpose, a California nonprofit public benefit corporation recognized by the IRS as a 501(c)(4), and has switched all payroll processing to run directly through Taxpayer's accounts. Taxpayer intends to undertake other actions consistent with the outcome and recommendations of a forensic audit including filing an amended Form 990 and amended W-2s by the end of the year upon completion of evaluation of the recent allegations, and demanding return of any excess benefit determined to have been conferred upon disqualified persons.
