B1G1 Giving, Inc has a close relationship with Buy1GIVE1 Pte Ltd, a Social Enterprise established in 2007 in Singapore. The Buy1GIVE1 Social Enterprise supports and inspires businesses around the world to promote giving that helps charitable organizations in 67 different countries accomplish their goals and serve their beneficiaries. Certain employees of the Social Enterprise supported B1G1 Giving, Inc by donating a portion of their time to various operational and record keeping functions the charity requires in order to fulfill its mission. The Social Enterprise also supports B1G1 Giving, Inc by donating to it funds sufficient to pay the bank service charges associated with the transfer of funds from B1G1 Giving, Inc. to the charitable organizations it supports. As a result of this arrangement, B1G1 Giving, Inc is able to transfer to these charitable organizations 100% of the funds donated by the businesses to the charities.

Part VI, Line 11b

The organization used a 3-step process to review this Form 990

Step 1 An initial draft of the Form 990 was prepared by the organization's Treasurer, working with organization's Secretary. Our Treasurer is a CPA.

This included a review of the financial statements prepared by the organization's accountants, as well as more in-depth review of data available in our systems to identify additional details, such as the identification of organizations donating more than \$5,000 and the identification of grant recipients receiving more than \$5,000, and other matters.

Step 2 This step included review of the initial draft of the Form 990 and all accompanying schedules by the organization's President along with two other individuals who are intimately familiar with the operation of the organization. This review was followed by discussion of questions and comments by these individuals with the Treasurer and Secretary.

Step 3 This step involved submission of the completed Form 990 and all accompanying schedules to the Board of B1G1 Giving, Inc. in June 2020. Having expanded the organization's Board in May 2020 to include additional members, this final review and the approval to submit the Form 990 included the three Board members who held Officer positions as of December 31, 2019, as well as the four new Board members. Submission of the Form 990 was unanimously approved by the expanded Board.

Part VI, Line 12c

In connection with the organization's Annual General Meeting, which took place on May 22, 2020, we re-distributed to all Officers and Directors of the company a copy of the B1G1 Giving, Inc Conflict of Interest Policy, together with a one-page Annex form to be completed by each of them. The Annex summarizes the recipient's obligations under our Policy, and requires a complete and accurate listing of all situations in which the recipient or an immediate family member

(anyone living the same household) has an employment relationship, a substantial (>5%) ownership interest, or a potential for conflict through service as an employee, director or committee member of another organization. The Annex further confirms that the recipient has received, read and understood the Policy, and has agreed to comply with its terms. Each Officer and Director completed and signed this Annex form, and returned it to the Secretary of the organization.

Part VI, Line 19

The organization did not begin operating until November of 2019. As a result, it did not have any financial statements available for viewing by the public during the 2019 tax year. However, having now completed the preparation of a limited financial statement for the two-month period of operation in 2019, as well as our initial Form 990 filing, we are making these materials available on our website simultaneous with their filing with the IRS. We have also added to our website links to our organization's corporate Bylaws, the Terms of Service governing operation of our program and website, the Cooperation Agreement entered into between B1G1 Giving, Inc. and the Worthy Causes it supports, and our Privacy Policy. We note further that our Conflict of Interest Policy is set forth completely as Section 7 of our Bylaws. The B1G1 Giving Board has approved each of these documents, and has directed that they be made available via our website on an ongoing (and, as needed, updated) basis.

Part VIII, Line 1d

Prior to the formation of B1G1 Giving, Inc., the support of the various charities in the B1G1 Giving network was conducted through a nonprofit entity registered in Singapore and known as B1G1 Giving Society. With the creation of the US entity, B1G1 Giving, Inc., it was no longer necessary to maintain the Singapore nonprofit. The \$29,110 amount noted in Line 1d represents a transfer from the Singapore entity to B1G1 Giving, Inc. of all funds then being held as donations designated for various charities, as well as a small amount representing donations designated for the operational expenses of the nonprofit (e.g., to be applied toward bank charges for transfers to the various charities). Subsequent to that final transfer, the Singapore nonprofit entity ceased operation, and it was subsequently closed down pursuant to applicable procedures in Singapore.

Part X11 - Line 2b

Since B1G1 Giving, Inc. began operations in November 2019, the organization did not believe it was necessary or frugal to have an audit covering two months. Instead, the organization will conduct an audit covering its inception, November 2019 through December of 2020. As soon as this independent audit is completed it will be posted to our website. From this point on, the Board will have independent audits completed on an annual basis. The audit covering the 14-month time frame will be an exception.
