In 2019 LEAD made grants to two academies - LEAD Monrovia Football Academy in Monrovia, Liberia (est. 2015) and LEAD Morocco in El Mansouria, Benslimane, Morocco (est. 2019). LEAD Africa provided \$117,200 of financial support to LEAD Monrovia Football Academy and \$32,082 to LEAD Morocco.
