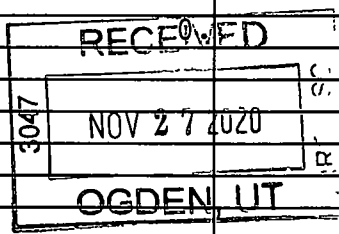

BOARD OF DIRECTORS AND NEW CPA FIRM WILL BEGIN FILING TIMELY RETURNS. INITIAL TAX RETURN FOR 2018 TAX YEAR WAS ELECTRONICALLY FILED AND ACCEPTED BY IRS ON NOVEMBER 9, 2020.
