Prior to the disbursement of funds, LUV's Senior Field Coordinator and Executive Director receives the requests and reviews each one independently and thoroughly, involving the Chief Financial Officer for a third level of review. Once the requests have been properly reviewed and approved, the funds are then transferred to the various Orphanage Directors by the Senior Field Coordinator. LUV is notified via email once the funds have been disbursed to the recipient organization(s). The Executive Director and other staff members of LUV make periodic trips to visit the recipients and ensure the monies distributed are being used for their intended program service purpose. In addition to these trips, the LUV Executive Director and/or Senior Field Coordinator holds weekly phone calls with each recipient director to discuss use of disbursed funds, as well as current conditions and any additional emergency needs.
