Part III, Line 28: The original mission of the NOLA Grannies was to provide food, water, diapers, toys, warm clothes, hygiene supplies and
information to asylum seekers as they made their way by bus across the country from detention centers to their sponsor's homes. The
Grannies also assisted families with bus tickets, meals when buses were missed or running late, and a warm welcome to help allay their fears
in an unknown environment. Before the current administration made a series of escalating changes to U.S. immigration policies, the Grannies
had assisted a total of 8,214 women, men, and children in 2019. The policy changes led to a slow-down and then to an eventual halt as
asylum seekers were required to remain in Mexico under the Migrant Protection Protocols. This policy virtually ended legal asylum claims
and the flow of migrants slowed to a trickle while the population of migrant detention centers throughout Louisiana swelled.

Part III, Line 29: With the flow of migrants reduced, the NOLA Grannies changed focus to assist those who were struggling in their new
circumstances. Because our funds were not being used in the bus station outreach, we created a small grant program to help local
grassroots organizations support their immigrant populations. In the fall of 2019, the Grannies invited five organizations to present
information on their needs to the larger Granny organization, invite volunteer participation, and request small grants. Through this outreach,
the Grannies began offering their time and skills to various projects including providing childcare while parents attended English classes,
providing cell phones to detainees and recently released detainees, teaching sewing classes to mothers, helping furnish a donated residence
for family members and attorneys visiting those in detention, providing Christmas presents and food for 90 children and families. The NOLA
Grannies have maintained funds for the bus station program when it reopens.
