THE ORGANIZATION WAS FOUNDED TO FOSTER, PROTECT AND PROMOTE THE WELFARE AND INTERESTS OF ITS MEMBERS AND THEIR FAMILIES, PRIMARILY THROUGH PROVIDING BURIAL AND MEDICAL BENEFITS TO ITS MEMBERS IN NEED. THE CROATIAN BENEVOLENT ASSOCIATION SPONSORS A COLLEGE SCHOLARSHIP PROGRAM TO PROVIDE PARTIAL SCHOLARSHIP BENEFITS TO ELIGIBLE APPLICANTS WITHIN THE LOCAL CROATIAN AMERICAN COMMUNITY.
