RAZE Leaders: The groundwork for this program started in the last third of 2019. In 2019, our RAZE Leaders program achieved two main goals. The first goal was to engage the youth in rural Arizona. To do this, the Executive Directors of RAZE spoke to hundreds of students at five high schools throughout rural Pinal county about the importance of civic leadership and the impact of civic engagement in small communities. This work allowed us to achieve our second goal, to create a diverse and dedicated group of students committed to participating in our 8-month leadership program and to take those skills back to their communities. An additional achievement is the diversity of our program. 80% of participants are female, 50% identify as a person of color, and 20% identify as members of the LGBTQ community. Finally, we have built the program curriculum, purchased program equipment and supplies, and leased a teaching space to accommodate the program. These achievements lay the groundwork for the future goal of building a pipeline of new, young leaders from within our rural communities. The ultimate goal is to have these young people become the decision makers of the future.

Census achievements. In 2019 our Census program was focused on educating the people of Pinal County about the upcoming 2020 Census. Our organization did this in coordination with other nonprofits, local leaders and officials. We worked in collaboration with the "Complete Count Committees" in Casa Grande and Eloy, Arizona. We participated in local events to provide information about the Census to the people in our communities. We also spent the end of 2019 educating and informing via our website, social media platforms and texting programs. We also grew in capacity and recruited two volunteers to help with this work. Much of the work done in 2019 laid the groundwork for 2020. It is our expectation that our 2020 Census work will continue to be successful and we will increase the count in historically undercounted communities.
