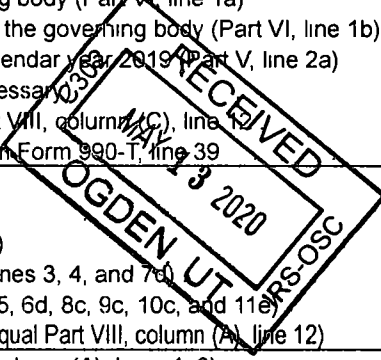

AGING IN PLACE A Vietnam Army veteran joined the Cleveland Police Dept and on duty was shot 9x by a sniper responding to a police call leaving him permanently disabled His wife had taken on the role of caregiver 2 years ago after retiring, his wife suffered a stroke leaving her disabled Despite his own disabilities, this veteran is caring for his wife He fractured his spine multiple times trying to help his wife up and down the stairs and getting in and out of the bathtub Their home was not suited for their disabilities Due to years of being on a fixed income and having limited mobility, their home was in disrepair Through grant appropriation, fundraising, volunteer coordination, and creating multi-organizational partnerships, their home received new paint, roof, landscaping, ADA bathroom, flooring, stair-lift, and house cleaning The veteran was signed up to receive VA benefits The repairs will allow them to continue living safely and indepently IN 2019 RWV MADE IT POSSIBLE FOR A TOTAL OF 14 VETERANS TO REMAIN SAFELY IN THEIR OWN HOMES

VETERAN ORGANIZATION ASSISTANCE VFW Post 2133 in Cleveland, OH was struggling to maintain membership and keep up with rising cost of energy bills The post had old dark paneling, inefficient lighting, and only folding tables and chairs for patrons to sit at The post was not ADA compliant Through grant appropriation and volunteer coordination, they received updated electrical, LED lighting, plumbing plus ADA bathroom fixtures, new flooring, drywall, paint, tables & chairs and landscaping As a result the post has greatly increased its membership and increased their number of hall rentals LED lighting and water saving bathroom fixtures has cut utility costs in half In 2019 RWV assisted a total of 8 US Military Veteran Organizations with general improvements including decorating, ADA modifications, energy saving upgrades, and landscape These costly improvements help ensure that these organizations will continue to be,

VETERANS WIDOW ASSISTANCE A Veterans widow lost her husband when was only 50 years old due to his exposure to Agent Orange in Vietnam The widow was diagnosed with cancer in 2018 and is being treated with chemo and radiation Between her battle with cancer and being elderly she was unable to get in and out of the bathrub forcing her into a nursing acility Through fundraising and volunteer coordination, this widow received a bathroom remodel The toilet was replaced with with an ADA compliant and energy efficient toilet The bathrub removed and replaced with a walk-in shower and grab bars New flooring, paint and vanity were also installed As a result she can now safely get in and out to bathe in 2019 RWV assited a total of 3 such widows of US Military Veterans
