 The Foundation focuses on three areas: 1. Education, by providing scholarships to students who will pursue an associate's or bachelor's degree program in Hospitality. 2. Crisis relief, by providing short-term hotel stays to individuals experiencing unexpected hardships and 3. Efforts to combat Human Trafficking, by providing training to the hotel industry. This will include partnering with individuals and other organizations in order to provide an overview of sex and labor trafficking and their impact on the hotel industry, to discuss common indicators of human trafficking and case examples, to give action steps on how to respond to and prevent human trafficking. The Foundation will organize fundraising events such as an annual Golf Outing and an annual Red Carpet Hospitality Gala, where all proceeds beyond expenses will go directly to the Foundation. We will also organize educational and similar seminars focused on our efforts related to Human Trafficking.
