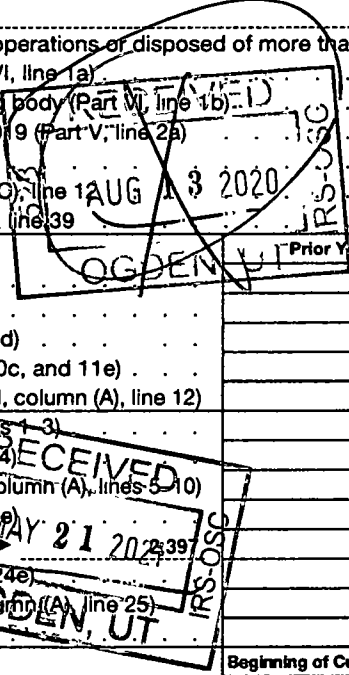

PUBLIC EDUCATION: DSW engaged in a range of activities to build support among the public for DSW's mission, the most prevalent of which was day-to-day interactions with reporters in order to amplify DSW's message in the news media. In addition, DSW (1) surveyed Democratic presidential candidates on their positions on decriminalizing consensual adult prostitution; (2) giving speeches; (3) producing brochures and briefing papers; and (4) responding to inquiries from the public.

CONFERENCES and COALITION BUILDING: DSW staffers attended and spoke at conferences; reached out to potential allies outside of conference settings; and strengthened relationships with existing allies with the purpose of building a stronger national coalition supporting the decriminalization of consensual adult prostitution. Specifically, DSW participated in conferences hosted by the American Public Health Association, the American Legislative Exchange Council, the National Association of Criminal Defense Lawyers, and the Adult Video News (AVN) Expo.
