Spent many hours on the phone trying to find children who had been separated from their parents at the border. Interpretations and translation to contact medical, dental, or other professional offices to make appointments or to convey information from the medical office to the patient. Assisting clients with applications - housing, employment, etc. Helping to register children in school and then interpreting when the teacher needs to talk to parents. Providing assistance in various other instances.

Providing emergency assistance to individuals who need it. Assistance includes providing gas for out-of-town medical appointments, rent or utility assistance when individual was ill and unable to work, purchase used household items for family that had just arrived from Guatemala, purchasing minutes on phone card, so client can talk to medical consultations; purchasing used outer wear, boots, hats, mittens, etc for clients who work outdoors in the winter, and to cover various other needs

Providing assistance with dental procedures. The client is responsible to pay \$50 for each appointment and the organization pays the rest of the costs, up to \$500/person. We assisted 12 people in 2019, some of whom had never seen a dentist before.

We provide English as a Second Language in 5 communities and one at a local dairy. Expenses include contracting a teacher in the area, if no volunteer available, as well as books. Directors, subject to the direction and control of the Board of Directors."**

Part VI, line 11b: A completed form 990 was given to each Board member and we discussed it at the Feb. 25th Board meeting.

**Part VI, line 12c: A copy of the Conflict of Interest (COI) policy was given to each Board member at our Jan 28th Board meeting. The main
concerns were discussed and all questions answered. Then each Director signed a statement that they had received a copy of the COI,
they had read it and understood the policy, they agreed to comply with the policy, and they understood that GLMC is charitable, and to
maintain its Federal tax exemption, it must engage primarily in activities which accomplish one or more of its tax-exempt purposes.**

Part VI, line 15a - of the positions listed, we only have a Director, and she is a volunteer and is not paid - anything.

**Part VI, line 15b - we have only 2 employees and neither meet the definition of "Key" employees and are not officers of the organization.
We did solicit information from 2 other non-profit organizations and our compensation package was inline with their pay scales for non-key
employees.**

Part VI, line 19: We have posted a sign on the bulletin board in the reception area that these documents are available upon request.

Part IX, line 11g - this expense was for a contract with a teacher for ESL (English) classes out of town.

Part IX, line 25 - This was the cost of a storage unit for excess tables, chairs, etc. that had been donated.
