The G20 process involves various platforms (ministerial meetings, engagement groups, etc.) that allow different sectors and communities to present their perspectives on global challenges, including sometimes their ideas and recommendations, to global leaders. The Organization exists to provide a forum for religious voices on the issues addressed by the G20 and related topics, and to encourage discussion between religious stakeholders, government leaders, and others on topics related to the priorities of the G20.

The Organization's purpose is to increase the vital roles that faith and religion play in promoting peaceful and harmonious relationships within and between nations by collaborating with religious thought leaders and policy makers to discuss global problems and their solutions.
