Discussion Forums. American Public Square at Jewell, which brings together non-likeminded people to engage in civil, fact-based discourse on challenging issues, serves as the community convener on behalf of KC Common Good to provide events and gatherings during which the problems faced by the community can be identified and addressed by those working to alleviate those problems. American Public Square at Jewell provides an additional platform from which people and organizations can share their work in order to garner support and become more effective in their efforts as a result of coordination and, when possible, collaboration. In 2019, together with American Public Square, KC Common Good co-hosted two events (see below). Note that no revenue was generated from these events which were free and open to the community. KC Common Good was a co-host of the programs in conjunction with its Management Agreement with American Public Square and did not pay any additional fees in order to be associated with the gatherings. "Medicaid: Expansion vs. Status Quo - What's the Price?" (November 4, 2019 at William Jewell College): During this event, a moderated panel of four experts from different perspectives discussed the fact that, despite high public approval ratings for Medicaid expansion, neither Kansas nor Missouri had implemented it. Community Resources Portal. Through an online portal, telephonic hotline and in-person partner venues, KC Common Good will highlight the organizations that are working to address the root causes of violence throughout the Metro, detail the ways in which their organizations can help, how people can access their services, et al. The platform will include general information, access to job openings, listings about skills training opportunities, a shared community calendar, and the like. Additionally, the platform will track specific metrics such as visits to the site, volume of resources available, numbers of job and other opportunities posted/filled, et al. It is expected that the initial functionality will be operational by 4Q2020. Partners in this effort include TeraCrunch and the United Way of Greater Kansas City's 2-1-1 organization. Data generated from portal usage will be analyzed by TeraCrunch and Rockhurst University to measure performance and enhance functionality. No revenue was generated from the portal in 2019. The cost to develop the portal is in excess of \$350,000; in 2019, \$175,000 was paid to the developer, TeraCrunch, for its initial work on the effort. Rockhurst University is a Section 501(c)(3) private university, United Way 2-1-1 is a public charity, and TeraCrunch is a for-profit technology firm.

Compensation was reviewed and approved by KC Common Good Board Chairman. There is no additional documentation available for what was essentially a negotiated compensation arrangement.
